FREQUENTLY ASKED QUESTIONS

What are the venue viewing hours?

We invite you to view the wedding destination throughout the week during our office hours, Monday to Friday from 10:00am - 5.00pm. We are also happy to accommodate site visits in the evening to suit your schedule as well as on Saturdays.

What is included in the venue rental fee?

- Tables (square or rectangular)
- Banquet Chairs
- Silver wears
- Glass wears
- Fine China
- DJ Table
- Table Numbers and Stands
- Table set up for Gifting, Guest registry and/or Cake Display
- Coatracks

Are there any decorating guidelines i must follow?

- You are more than welcome to arrange your own décor
- Due to fire regulations, the use of open flame candles is strictly prohibited. Candles may be used as long as the flame is enclosed in a non-flammable structure that meets our guidelines. All candle center pieces not supplied by the hotel must be pre-approved by your Wedding Manger
- The use of nails, tacks and double-sided tape is not permitted in any function space. Charges will apply as a result of damages caused by the use of these items
- Smoke or bubble machines are not permitted in the hotel without prior approval
- Confetti is also prohibited and a cleanup fee of \$200 will apply if confetti is used
- All decor, gifts, and personal items must be removed from the event space the evening of your wedding. Should you decide to leave behind items, a cleanup fee of \$30 per hour (per staff person, for a minimum of three hours) will be added to your bill. In addition, items left behind must be claimed within 72 hours after the function date or they will be disposed of by the club.

Is there a minimum food & beverage spend?

- All of our venue spaces have a minimum revenue requirement in food and beverage (before taxes & gratuities) that must be met. Please note that it is only a minimum, and not the final price.
- All prices advertised and charged are in Canadian funds. Food & Beverage prices are subject to 18% service charge, 5% GST, 6% PST. Liquor sales are subject to 18% service charge, 5% GST, and 10% Saskatchewan Liquor Tax
- You are not required to obtain a liquor license as the hotel provides the alcohol.
- Alcohol will be served until 12:30am. Last call is at 12:01am. in order for the event room to be vacated by 2:00 a.m

Is outside catering allowed?

- We do not allow outside food and/or beverages, due to food-safe regulations and Saskatchewan regulations, the club is required to provide all food and beverage for the event with the exception of a wedding cake from a licensed baker. You will be provided with a release form that must be completed prior to the cake's delivery. Should you wish to provide cultural/ethnic desserts, our team is happy to discuss options

Is there a corkage fee?

- We do not charge a corkage fee as we do not permit outside food and beverage

Could we bring our own cake?

- Absolutely! Cakes and cupcakes are allowed. The club does not provide these items Our club is pleased to provide complimentary cake cutting.
- If you prefer that our staff serves your cake individually to each guest, a cake plating fee of \$5.00 per guest will be applied.
- Alternatively, we are happy to cut your cake by one of our banquet associates and that will be served on the buffet, or served as a "Late Night Snack".

What vendors do I need to make arrangements with?

- You will need to arrange for the entertainment, wedding planner, florist, photographer, videographer, decorator, hair dresser and makeup artist. Please provide us with a list of all vendors you have selected; including contact names and telephone numbers.

How do I arrange a menu and menu tasting?

- A complimentary wedding tasting will be arranged for all confirmed wedding receptions with a plated dinner menu. For wedding receptions with a buffet selection we are happy to provide a discount to attend our Sunday Food Court Buffet in the restaurant in advance of your wedding.

- Appointments are scheduled accordingly with our Manager

Our team would be delighted to work with you on catering a custom menu. *Please note that our banquet menus are updated annually*

Menus and details should be finalized with your Manager a minimum of one month prior to your event. A final count of the number of reception guests is required at least seven business days prior to the wedding

Golf Kenosee CLUB 19 Restaurant is committed to accommodating your guests' dietary restrictions. Please advise your Manager of all dietary restrictions and allergies at least seven days prior, when providing final numbers additional charges may apply

What items should the couple provide the club?

- The couple may provide the club with the following items for storage prior to event setup: guest book and pen, centerpieces, bridal toasting glasses, cake knife and lifter, favours, place cards and/or seating chart, engagement photos, disposable cameras and any other miscellaneous items.

- You will need to arrange for someone in your party to set up these items prior to the start of the event and remove these items the same evening the event concludes. Wedding presents and cards must be removed from the event space once the reception is over

Do we allow to remove food from the premises?

Insurance restrictions & Saskatchewan Food Safety Regulations prohibit the Club from allowing leftover Food & Beverage to be removed from the premises. Therefore, no "to-go" boxes will be provided for any meal functions.

What time must the event end?

•Your celebration may continue until 1:00am. Due to regulations, all live and recorded music cannot be extended past 1:00am and alcohol service may go no later than 12:30am.

What are the deposit amounts and when are payments due?

•A \$500 non-refundable deposit is required upon signing your contract. One month prior to the wedding, 50% of the cost is due for function space rental, estimated food and beverage, visual equipment, and miscellaneous expenses. The remaining balance of the event is due one week prior to the event date, based on the total estimate of charges. The Club requires a credit card on file to settle any variance to the estimate

What happens if i choose to cancel my event?

Your deposit will be refunded 100% if the event is cancelled 90 days prior, and 50% if cancelled 60 days prior. Any cancellations after 60 days will not be subject to any refunds. Additional cancellation charges will be applied as outlined in your contract.

What service charges and sales tax amounts do i have to pay?

All prices advertised and charged are in Canadian funds. Food & Beverage prices are subject to 18% service charge, 5% GST, 6% PST. Liquor sales are subject to 18% service charge, 5% GST, and 10% Saskatchewan Liquor Tax. Please note that the service charge is taxable.

Do we allow you to go the golf course?

•Your safety is more important to us for this reason we don't allow to go to the golf course. But you are more than welcome to take some photos on the first tee with a panoramic view. To do so you must speak to the manager and get approved.
